- B) IF YOU CAN'T OFFICIATE AN ASSIGNED GAME, ***IT IS YOUR RESPONSIBILITY***, NOT THE ASSIGNORS TO GET A QUALIFIED ASA UMPIRE TO COVER YOUR GAME.
- C) IF YOU MUST TURN BACK GAMES, OUR ASSIGNORS WILL TRY TO HELP IF YOU PROVIDE THEM WITH ADEQUATE LEAD TIME.
- D) IF YOU DO NOT SHOW FOR A GAME AND THE GAME IS NOT PROPERLY COVERED, THE FOLLOWING ACTIONS WILL BE TAKEN:
 - 1) 1ST OFFENSE WILL BE A WRITTEN WARNING NOTICE.
 - 2) 2ND OFFENSE WILL BE A MONETARY FINE, EQUAL TO THE GAME FEE FOR THE GAME YOU DID NOT OFFICIATE.
 - 3) 3RD OFFENSE WILL RESULT IN THE WITHDRAWAL OF ALL ASSIGNED GAMES.
- E) OURS IS A SERVICE ORGANIZATION, UNFORTUNATELY WE ARE REMEMBERED FOR OUR LAST BAD IMPRESSION, NOT ALL OF OUR GOOD ONES.
